LCFS Walks


The past few months LCFS has held many walking events ranging from spiritual walks to a walk/run/bike event downtown.

Pando Aspen Grove of Community Height is Now Open!

LCFS/The Foundation for LCFS, along with our collaborative partners, have been working on a new program: Pando Aspen Grove of Community Heights (Pando). This new program is located at 5626 E. 16th Street and is the first Permanent



Supportive Housing Program in the Indianapolis metro area specifically serving young adults ages 18-24 years old who have been involved in the child welfare/foster care system.



The 30 one-bedroom unit apartment complex is now open with several tenants already settling into their new homes. Individuals are referred to the program through the Indianapolis Coordinated Entry System.

Some of the services LCFS provides through Pando include helping clients gain access to health insurance and supplemental food programs, nutrition and cooking classes, legal

aid, budgeting and finance management, case management and mental health services,

employment and career planning, and access and connections to educational enhancement opportunities. All these services are offerred at no cost to the clients at any point while residing at Pando.

The onsite property manager at Pando, Catinya Brown, who has worked with TWG for more that 2 years said, "This is a fantastic program going on here at Pando." Brown has her bachelor's degree in social services and has a background of working in mental health as well as with both children and adults



diagnosed with autism. "I loved working in social services in the past and I was surprised that those experiences were coming back around again in my current career."

Brown understands that some clients may arrive at Pando still in the mindset that this is transitional housing. Still, Brown hopes the clients can grow at Pando and that when they move on to other places, they can take the life skills they learned while living there with

them. Operating with the "Housing First" approach, the Pando program supplies an array of voluntary supportive services to help young adults reach their education, employment, health, and community integration goals.

LCFS along with its partners is hosting a panel discussion and Grand Opening

for Pando on Wednesday, July 28, 2021. The Panel Discussion includes guest speakers to address some of the challenges associated with homelessness. The Pando Grand Opening follows the panel discussion. The event includes guided tours of the new Pando facility after the ribbon-cutting ceremony.
